# **ACCREDITATION LICENCE**

Special Olympics Bharat	State Program/ Committee existing under the laws Of
Special Olympics Bharat ("S.O.B.") makes	the following commitments and representations in
connection with the Program's request that	SPECIAL OLYMPICS BHARAT grant or renew the
Program's accreditation. The jurisdiction of th	e Program will be in the State / or Union Territory of

#### 1. Compliance with Accreditation Standards

The State program certifies to SPECIAL OLYMPICS BHARAT that all statements in the Program's Accreditation application are true and correct and that the Program complies with all of the Accreditation standards. The Program will inform SPECIAL OLYMPICS BHARAT immediately in writing, if there is any material change in the Program's compliance with any accreditation standard after the date on which the Program signs this Accreditation License.

### 2. General Rules

As a condition of obtaining and maintaining its accreditation, the State Program Committee agrees to comply with the Special Olympics Official General Rules as brought out by Special Olympics Inc. from time to time including the other Uniform Standards (as defined in the General Rules), and to participate actively in the Special Olympics Program Development System. The State Program also agrees that if it fails to comply with the General Rules/Bye laws then that failure may result in SPECIAL OLYMPICS BHARAT undertaking the following action:

- 1. Revoking the State Program/Committee accreditation or
- 2. Not renewing its accreditation at the end of the Accreditation Period or
- 3. Taking other action(s) in accordance with the S.O. Official General Rules

#### 3. License to use Special Olympics Marks

- **3.1 Purpose of the License: Conditions SPECIAL OLYMPICS BHARAT, hereby** grants the Special Olympics Bharat State Program a license during the Accreditation Period to use the name "Special Olympics", the Special Olympics Logo, and certain other Special Olympics Marks (the foregoing name, logo and marks are referred to collectively as "**Special Marks**") solely for the purpose of conducting the Program's activities in its jurisdiction as authorized by the General Rules and that this license is conditional upon the State Program's continuing compliance with the General Rules / Bye laws during the Accreditation Period. The State Program agrees and undertakes that it will not mislead the public by using these distinguishing marks, logos and signage's, if it's accreditation is either cancelled or revoked.
- 3.2 Right of user of 'SPECIAL OLYMPICS AND ALLIED LOGOS" The State Program/Committee acknowledges that SPECIAL OLYMPICS BHARAT is the sole entity that has the right to give accreditation to any sub-program that would enable the said accredited sub-Program to participate in regional and international games. As such the State Program agrees and undertakes not to take any other action that would dilute or erode the sanctity of the said "Special Marks" signifying the chain of affiliation of the programs from District to National to International. This undertaking will apply to all present and future signs, logos and or marks categorized as "Special Marks" the use of which would signify to the public at large that the programs are connected with and are duly authorized by "Special Olympics Bharat".

#### 3.3 Use of Special Olympics Marks

The State program agrees to use the Licensed Marks solely in accordance with the General Rules and warrants that it will not authorize any third party to use or reproduce any Special Olympics mark in connection with any activity or event unless the Program complies with the Contract polices in Section 8.07 of the General Rules and all other requirements Of the General Rules applicable to that activity or event. Specifically, the program shall only use the words "Special Olympics" when directly followed by the Program's jurisdiction. All

returns generated in connection with the Program's use of the Licensed Marks shall accrue to the benefit of Special Olympics Bharat

- **3.4** <u>Accreditation Period-</u> The Accreditation Period shall be from 1<sup>s</sup>January 2014 to 31<sup>st</sup> December ....... year unless sooner terminated or superseded by a subsequent Accreditation License. Special Olympics Bharat shall have the right, but not the obligation, to unilaterally extend the Accreditation Period if Special Olympics Bharat deems such extension appropriate.
- 3.5 Acquisition/Transfer/Disposal of AssetsThe State Program shall at the time of applying for accreditation submits the list of all assets. At the time of application and renewal of accreditation, the State Program shall supply a fresh list of all assets in kind, donations received and the like for the year of Accreditation without which the application shall be deemed to be incomplete. The accruals, during each year of accreditation, shall be deemed to be the property of Special Olympics Bharat left in trust with the State Branch/Sub-Program, as long as the Accreditation is current. The said property shall be taken over directly by Special Olympics Bharat and handed over from one State Program to next Accredited State Program.

#### 4. Relationship between SO Bharat State Program and Special Olympics Bharat.

- 4. The State Program shall conduct all of its activities in accordance with all laws and regulations of its Jurisdiction and in whatever alternate form as approved by SPECIAL OLYMPICS BHARAT.
- **5** The State Program acknowledges that it is only a Sub-Program of SPECIAL OLYMPICS BHARAT and that this Accreditation License does not grant the Program any right to hold itself out to any third party as the agent of SPECIAL OLYMPICS BHARAT or of any other Accredit Ted Program, or to incur legal or financial obligations on behalf of Special Olympics Bharat or any other Accredit Ted Program.

#### **6.Effect of Revocation of Accreditation**

- **Revocation of License** If SPECIAL OLYMPICS BHARAT revokes, suspends or does not renew the State Program's accreditation, the license granted by this Accreditation License to use the Licensed Marks shall terminate immediately, and the Program shall promptly cease all use of the Licensed marks, subject only to the fulfillment of any outstanding contractual obligations to third parties that the Program entered into in accordance with the General Rules.
- 6.2 Enforcement- SPECIAL OLYMPICS BHARAT is, hereby granted the right to stop misuse and misrepresentation by the State Program by continued holding out that it has accreditation and non-stoppage of the user of all identification and linking marks etc. specific performance, by court order, if necessary, of the State Program's obligations under this Accreditation License and the General Rules, including without limit enforcement of Special Olympics Bharat by means of all remedies available to SPECIAL OLYMPICS BHARAT under applicable law, including the right to enjoin unauthorized use and the right to recover all money, property or other assets that the Program receives or obtains due to its affiliation with SPECIAL OLYMPICS BHARAT.
- 6.3 Post-Revocation Procedures— If the State -Program's accreditation is revoked, suspended, denied for any reason, the Program agrees to take whatever steps may reasonably be required by SPECIAL OLYMPICS BHARAT to facilitate SPECIAL OLYMPICS BHARAT's establishment and accreditation of a new accredited program in its jurisdiction in order to ensure continuity of the Special Olympics programs available in that jurisdiction. Such steps shall include all possible actions reasonably designed to ensure that all money, in-kind donations, Property, and assets of any type that were acquired by the Program through its affiliation with Special Olympics are surrendered by the Branch/Sub-Program and used for the organization and operation of a new accredited program in its jurisdiction.

## 7. Effect of Accreditation License: Definitions

The program acknowledges that the commitments and representations made in this Accreditation License are a material part of its application for accreditation and that SPECIAL OLYMPICS BHARAT is relying on this License in determining whether to grant or renew the State Program's accreditation. The State Program warrants that it has all requisite authority to make the commitments and representations contained in this Accreditation License and that it does so with the intention of being legally bound by them. Any words and phrases that appear in this Accreditation License with initial capitalization that are not defined in this License shall have the meanings given to those terms in the General Rules/ Byelaws. This Accreditation License supersedes and replaces all prior Accreditation Licenses and Accreditation Licenses.

The rights and obligations of the State Program under this Accreditation License shall not be assigned or otherwise transferred to any third party without SPECIAL OLYMPICS Bharat's prior written consent.

#### 8. Severability

It is the intention of the parties to have the terms of this Accreditation License complies with all applicable local laws. If any provision of this Accreditation License or its application to particular circumstances is determined to be invalid or unenforceable, the remainder of this Accreditation License shall not be affected by such invalidity or unenforceability, and all other provisions of this Agreement shall continue to be valid and binding upon both parties. Each party shall use good faith efforts to comply with the applicable law(s) of the applicable jurisdiction.

The State program agrees that this Accreditation License shall, when signed on behalf of SPECIAL OLYMPICS BHARAT, be a binding and enforceable contract between the Program and Special Olympics Bharat during the period of accreditation.

## 9.Jurisdiction

The jurisdiction of this Accreditation for any disputes shall be in Delhi.
