- 1. As per the provisions scheme, the admissible assistance would be provided to the above team members.
- 2. Section 9 of FC (R) Act, 1976, provides inter alia that no member of a legislature, office bearer of a political party, judge, Government servant or employee of any corporation shall accept any foreign hospitality without the prior permission of the Central Government. In case, any team member is covered under the above act, he/ she obtain the prior permission from Ministry of Home Affairs before their departure to Dhaka Bangladesh.
- As regards foreign exchange required for above participation, the Team Coach is requested to approach authorized dealers for getting the foreign exchange in view of RBI circular No. 41 A.D (M.A. Series) dated 25.1.97.
- 4. Such of the team member who might be Central Government Servants are to be treated as on duty (Which include deputation abroad) in respect of the participation by the Departure / Office in which they are employed in teams of Department Personnel & Training O.M. No. 6/1/85-Est. (Pay-1) dated 30.1.1989. The federation should inform their employing Department/ Office accordingly.

- 6. A report on the visit of the team along with its performance / achievement in the above event may please be sent to TEAMS Division, SAI within 7 days of the return of the team to India along with some action photographs, if possible.
- 7. Before departure, a report on dope test of the team members may be obtained from DG, NADA New Delhi.
