- A sum of ₹ 1,31,950/- (Rupees One Lakh Thirty Thousand Nine Hundred and Fifty
 Only) towards 100% of the total estimated cost for visa & insurance to Mr. Harpreet Singh for
 making smooth arrangements.
- 2. A sum of ₹ 2,72,000/- (Rupees Two Lakh Seventy-Two Thousand only) for boarding, lodging & local transport (domestic) was approved for the training and transit camps to be held at Manav Rachana University, Haryana from 6th July to 12th July,2024. The payment for the same will be made on receipt of the original bills from the Administrator, JLN Stadium, New Delhi.
- Out of Pocket Allowance i.e. Rs. 1,61,850/- for 13 members @ USD 25 per day per person x
 Rs. 83/- (approx.) i.e. Rs. 12,450/- per for 06 days to be transferred directly to the bank account of each participant in the said events.
- 4. The settlement of training and transit camps to be held at Manav Rachana University, Haryana will be done by the Administrator, JLN Stadium, New Delhi on receipt of expenditure details along with bills/vouchers/invoice within 15 days after the completion of the event.
- 5. The settlement of participation in the Special Olympics Gothia Cup at Gothenburg, Sweden, from 14th to 18th July 2024, Haryana will be done from <u>TEAMS Division</u> on receipt of expenditure details along with bills/vouchers/invoice within 15 days after the completion of the event.
- 6. The amount sanctioned herein will be drawn by the Drawing & Disbursing Officer, Sports
 Authority of India on the prescribed bill immediately for disbursing the same to grantee
 through Electronic Clearing System. This grant is of non-recurring nature.
- 7. The grant is subject to the conditions mentioned below: -
- a. The grantee shall not divert the grants and entrust execution of the scheme or work concerned to another Institution or Organizations and shall abide by the terms & conditions of the grant. If the grantee fails to utilize the grant, for the purpose for which the same has been sanctioned, the grantee will be required to refund the entire amount of the grant with interest thereon @ 10% per annum.
- b. The Expenditure statement along with bills/vouchers duly verified should be submitted within 30 days along with the performance-cum-achievement report in respect of the above event for which the grant has been sanctioned should be forwarded to the TEAMS



DIVISION, Sports Authority of India with a copy to Government Observer within one week of the completion of event.

- c. That some photographs of the events, i.e. events, medal winners etc. with sample invitation cards for opening and closing ceremony and copies of newspaper clippings related to the event preferably in National and Regional dailies be sent to this office along with performance-cum-achievement report.
- d. That the amount in INR will be subject to the actual rate of Foreign Exchange on the date of payment by the Federation. The difference, if any, in INR will be adjusted.
- e. There is no reason to believe that the grantee is involved in corrupt practice.
- f. That no advertisement of Tobacco and Liquor will be displayed during the event, the breach of which entails the cancellation of grant.
- g. Amount of grant should be utilized only for the purpose for which it is sanctioned and unspent balance of grant shall be refunded by the Mr. Harpreet Singh immediately after conclusion of the event.
- h. The grant is further subject to the conditions laid down in General Financial Rules as amended from time to time.
- The fact the program is sponsored by the Ministry of Youth Affairs and Sports/ Sports
 Authority of India should be prominently highlighted and displayed while inviting people
 and holding functions/programs/events etc.
- j. When the Sports Authority of India/Government of India/State Government has reasons to believe that the sanctioned money is not being utilized for the approved purposes, the payment of the grant will be stopped. If the reply to the show cause notice is not satisfactory, the earlier grant will be recovered with interest as mentioned in Clause IV above.
- k. The grantee institution or organization should exercise reasonable economy in the working of the approved projects.
- I. As per GFR-212(1), the accounts of grantee institution or organization shall be opened to inspection by the Ministry of Youth Affairs & Sports/Sports Authority of India and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and Internal Audit of Sports Authority of India, New Delhi, whenever the grantee is called upon to do so.



- 8. The above sanction has been issued under the powers delegated to the Director General/Secretary/Executive Director of Sports Authority of India. It is certified that the grant being released is in conformity with the rules and regulations of the scheme as approved by the Ministry of Youth Affairs & Sports.
- The amount of grant will be debitable to the Major Head 49.0500 (Assistance to National Sports Federations) for the Financial Year 2024-25 to Mr. Harpreet Singh.
- 10. Travel Sector: For Camp: Local transportation will be reimburse on as per actual basis as per the Assistance to NSF norms.

For competition: Camp Venue - Gothenburg, Sweden & back as per actual
